Pre-application Notice Limited Registration

An employer (applicant) can use this form to notify the Teacher Registration Board of Western Australia (TRBWA) of their intention to make an application for Limited Registration on behalf of a teacher. This notice may be used in circumstances where a teacher is required to teach immediately.

If a teacher is required to teach prior to an *Application for Limited Registration* (Application) being granted, a *Pre-application Notice - Limited Registration* may be lodged with the TRBWA.

The lodgement of an Application is the second part of a process if a *Pre-application Notice* was lodged with the TRBWA. The Application must be made to the TRBWA within 14 days of the *Pre-Application Notice* being lodged and it must be accompanied by the appropriate fee, as listed on the Fees page of our website (trb.wa.gov.au).

If this process is followed, the grant of registration is backdated to the date the *Pre-Application Notice* was lodged with the TRBWA.

Failure to make an *Application* within 14 days may lead to an offence being committed by the **applicant** and the **teacher** under the *Teacher Registration Act 2012* (Act) sections 6 and 7:

- a person must not teach in an educational institution unless the person is a registered teacher; and
- a person must not appoint, employ, engage or give permission to another person to teach in an educational institution unless the other person is a registered teacher.

An employer may require a teacher to teach immediately where the teacher already has been granted Limited Registration with another educational institution within the past 12 months. In these circumstances, the employer may lodge a Pre-Application Notice and the lodgement of an Abridged Application for Limited Registration must be made to the TRBWA within 14 days.

Information about completing and submitting a Pre-Application Notice - Limited Registration

Teacher: A 'teacher' is a person who satisfies the statutory requirements for Limited Registration and has been offered a teaching position. The person responsible for completing and submitting this *Pre-Application Notice* is the employer or a delegate who is authorised to hire teaching staff.

Applicant: The 'applicant' is the employer and is usually the Department of Education, the Catholic Education Office or the school's governing body.

- In cases where a teacher is required to teach prior to the grant of registration, an applicant must lodge this Pre-application Notice - Limited Registration with the TRBWA.
- A teacher may commence teaching on the same day the notice is lodged at the TRBWA and is strictly conditional an on Application being made within 14 days of the *Pre-Application Notice*.
- Failure to submit the Application to the TRBWA within 14 days will render the teaching unlawful and the teacher must cease teaching immediately. If the application is not submitted within the 14 days, the employer (applicant) and nominated teacher may be prosecuted under sections 6 and 7 the Act.

This *Pre-application Notice* can only be used for one 'teacher'. A teacher is a person who satisfies the statutory requirements for Limited Registration and has been offered a teaching position. The person responsible for completing and submitting this form is the employer or a delegate who is authorised to hire teaching staff.

The 'applicant' will be responsible for paying the registration fee.

The employer must be named. Note that a school principal is rarely, if ever, an employer. The employer will usually be the Department of Education, the Catholic Education Office or the school's governing body. In the case of an education and care centre, the provider's or operator's business name and contact details must be provided.

The employer's delegate is usually the school principal or nominated supervisor. This is the person with whom the TRBWA will liaise with respect to the application and the Limited Registration, if approved, of the teacher.
